PLEASE READ AND INITIAL

_____ I understand that all tuition fees are due by December 1st, 2020. On December 2nd, 2020, a late fee of \$50 will be applied to my account. As of January 1st, 2021, 3% monthly interest will be charged to overdue accounts.

_____ I understand that if I am not paying in full upon registration, I will have monthly instalments due, either by post-dated cheques or automatic withdrawal from a credit card. The monthly payments (or bi-monthly if preferred) will be divided by the number of payments dates between registration and December 1st, 2020.

_____ I understand that the registration fee is non-refundable (\$15 per student/\$25 per family) and it is due upon registration.

_____ I understand that due to the ongoing concerns of Covid-19, in the event of a second wave (shut down) classes will resume temporarily online where applicable or will double up upon re-opening. As we already have to limit how many students are in a classroom, refunds will not be available, in this event.

_____ I understand that once the dance season has commenced, I will have 2 weeks to withdraw from a registered class to receive a refund (less the registration fee and \$15/class attended). After that time, Spirit of Dance will be happy to place your child in a different class or offer a credit, if applicable.

_____ I understand that classes will not be pro-rated.

_____ I understand that each discipline of dance will perform a routine in our year-end recital, and therefore, will have a costume that can either be purchased or fundraised. The costume invoice will be due by November 1st, 2020. Costumes will vary in prices anywhere from \$75 to \$150.

_____ I understand that I may participate in the fundraising program offered at Spirit of Dance. I also understand, that fundraising privileges can be revoked if the participant does not abide by the regulations set forth. I may use my personal fundraising for costumes ordered by Spirit of Dance (including costumes sold on consignment), dance shoes ordered by Spirit of Dance or shoes sold on consignment at Spirit of Dance, tights ordered by Spirit of Dance, additional costume accessories ordered by Spirit of Dance, competition entry fees booked by Spirit of Dance, dance workshops, hotel costs for out of town competitions or workshops for immediate family only, booked by Spirit of Dance, bus travel organized by Spirit of Dance for out of town competitions or workshops. I understand that I may not use my personal fundraising for dance tuition, recital tickets, dance wear merchandise sold at Spirit of Dance or cash value. The fundraising that I contribute can be used during the following dance season: June 2020- August 2021. I understand that if I register the following year, my fundraising will be forwarded to the new year. I understand that when my child (dancer) is no longer a registered student at Spirit of Dance, any fundraising I have contributed to the account will be forwarded to the general fundraising slush fund. Fundraising is non-transferable to other members of Spirit of Dance.

_____ I understand that I will receive a student handbook that will outline important dates and information, including recital, photo dates, competition dates etc. or that I can check the calendar on the website www.spiritofdance.org to view this information.

_____ I understand that my child will need to wear the proper attire and footwear for class. (Information will be provided in a student handbook.)
